

# TE KAUWHATA COLLEGE (115)

## Enrolment Scheme

Effective from 24 April 2023

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

### Home Zone

**All students who live within the home zone described below (and shown on the map) shall be eligible to enrol at the school.**

*The zone begins where Kaawa Stream meets the sea, west of the Baker Road and Port Waikato-Waikaretu Road intersection. It follows the Kaawa Stream east, to include 1791 Port Waikato-Waikaretu Road, to where it is met by Pungatiki Stream, and from this point stretches in a direct line east to the Baker Road and Wairamarama Onewhero Road intersection (Baker Road is in-zone).*

*From the Baker Road and Wairamarama-Onewhero Road intersection the boundary extends east (to include 2705 Wairamarama-Onewhero Road) to cross Matakītaki Road just past 226 Matakītaki Road (addresses above this number are not included).*

*From 226 Matakītaki Road the boundary extends northeast to meet the Mangatia Stream, follows the Mangatia Stream to where it meets the Opuatia Stream and follows the Opuatia Stream to where it is crossed by Highway 22 (all of McCutchan Road is therefore included, but not Allen & Eyre Road, Fleming Road, or Thompson Tonga Road).*

*From where the Opuatia Stream is crossed by Highway 22, the boundary loops to the intersection of Ramsey and Chapman Roads (the zone does not include Ramsey Road or Chapman Road addresses between Highway 22 and the intersection of Chapman and Ramsey Roads). From the intersection of Ramsey and Chapman Roads the zone extends north and east to include Chapman Road addresses between the intersection of Ramsey and Chapman Roads to the intersection of Chapman and Pukekawa Churchill Road.*

*From the intersection of Chapman and Pukekawa Churchill Road the zone extends north to include 875 Pukekawa Churchill Road, and from here the boundary follows the Waikato River north to where it is met by the Whangamarino River. The zone then follows the Whangamarino River to where it is met by the Maramarua River, and follows the Maramarua River to a point west of Feist Road (Feist Road is included). It then extends northward to the intersection of Rawiri Road and State Highway 2 (Rawiri Road is not included).*

*From the Rawiri Road and State Highway 2 intersection the zone extends west to include all of Maxwell Road, but not State Highway 2 addresses east of the State Highway 2, Maxwell Road and Coalfields Road intersection.*

*South of the State Highway 2, Maxwell Road and Coalfields Road intersection the zone extends to include all of Coalfields Road, Kopuku Road, and Dalgety Road. It crosses Ferndale Road at 285 Ferndale Road (addresses above this number are not included), includes all of Molloy Road and then follows the northern boundary of the Maramarua Forest, excluding McWatt Road to cross Okaeria Road at 683 Okaeria Road (addresses above this number are not included), and from here loops east and south*

*through the Maramarua Forest (including Stannard and Paulsen Road) to the end of Waipuna Road (which is included).*

*From the end of Waipuna Road the boundary extends southwest to cross Ohinewai Road at 228 Ohinewai Road (addresses below this number are not included), then west to include Hoult Road and NZBC Access Road (but not Mangapiko Valley Road) to the Storey/Waiterimu/Taniwha/Matahuru Road intersection. The zone includes all of Matahuru Road but does not include any of Storey or Waiterimu Road.*

*From the intersection of Storey/Waiterimu/Taniwha/Matahuru Roads the zone boundary extends west, to include Rawson Road, and crosses Waikare Road at 167 Waikare Road (addresses below this number are not included). From 167 Waikare Road the boundary travels north and west through Lake Waikare, to cross Lumsden Road north of 338 Lumsden Road (this address and Lumsden Road addresses below it are not included), west again to cross the Waikato Expressway (SH 1) at the southern end of Armitage Road (Paetai Road and Armitage Road are included but not Ohinewai North Road).*

*From the southern end of Armitage Road the zone extends west to the Waikato River, then follows the river south before extending west to cross Te Ohaki Road at 856 Te Ohaki Road (addresses below this number are not included). The boundary then extends west to cross Rotongaro Road at 507 Rotongaro Road (addresses below this number are not included). Beverland Road is included in the zone.*

*From 507 Rotongaro Road the boundary extends west through Lake Whangape and then follows the Awaroa Stream to a point east of the Awaroa Landing Road and Highway 22 intersection. From the Awaroa Landing Road and Highway 22 intersection the zone extends west to include all of Waikaretu Valley Road, as well as south down Richardson Road from the intersection with Waikaretu Valley Road to 173 Richardson Road (addresses above this number are not included).*

*From 173 Richardson Road the zone extends southwest to the intersection of Pukerawa Road, Te Akau Coast Road and Matira Road (of these roads only Pukerawa is in zone). From the Pukerawa Road, Te Akau Coast Road and Matira Road intersection the zone extends west to the coast, and then follows the coast north to where Kaawa Stream meets the sea, where the zone began.*

Note: Both sides of all streets and roads included in the above description are included unless otherwise stated.

Proof of residence within the home zone will be required.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date which will be published in a daily or community newspaper circulating in the area served by the school. This will enable the board to assess the number of places which can be made available to students who live outside the home zone.

### **Out of Zone Enrolments**

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

**First Priority** this priority is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.

**Second Priority** will be given to applicants who are siblings of current students.

**Third Priority** will be given to applicants who are siblings of former students.

**Fourth Priority** will be given to any applicant who is a child of a former student of the school.

**Fifth Priority** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.

**Sixth Priority** will be given to all other applicants.

If there are more applicants in the second, third, fourth, fifth, or sixth priority groups than there are places available, selection within the priority group must be by ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

**Applicants seeking second or third priority status may be required to give proof of a sibling relationship.**
